IN THE PARISH OF EASTON ON 15<sup>TH</sup> APRIL 2018

TEMPORARY RESTRICTION OF TRAFFIC MOVEMENT

1. ORDER temporarily restricting the use by vehicles of the:
  - 1) Temporary One-Way (restricting westbound traffic): C574 Dereham Road (from a point 105m north-west of junction C162 Long Lane in a westerly direction to junction U78206 Church Lane).
  - 2) Road Closure: C574 Dereham Road (junction U78206 Church Lane in a westerly direction to junction U78213 Church Lane); U78213 Church Lane (full length); U57213 Red Barn Lane (full length); C174A Colton Road (junction U57213 Red Barn Lane in a southerly direction to junction U78018 Norwich Road).
  - 3) Road Closed: U78018 (full length); U57018 Norwich Road (full length).
  - 4) Temporary One-Way Restriction (restricting southbound traffic) and Temporary 30mph Speed Limit: C167 Barnham Broom Road (full length); C167 Honingham Road (junction C167 Barnham Broom Road in a southerly direction to junction U78016 Colton Road).
  - 5) Road Closure: U78016 Colton Road (full length); U76061 Church Lane (full length); U78062 Church Lane (full length); U78060 The Street (junction U78062 Church Lane in a southerly direction to junction U78181 Marlingford Road); U78181 Marlingford Road (full length); C174A Colton Road (junction U78181 Marlingford Road in a southerly direction to junction C162 Barford Road).
  - 6) Road Closure: C162 Barford Road (full length); C162 Bawburgh Road (full length).
  - 7) Road Closure: U78062 Bawburgh Road (junction C162 Bawburgh Road in a northerly direction for a distance of 695m)

in the PARISH OF EASTON

2. Save as provided in Article 3 of this Order and whereas the Norfolk County Council as Traffic Authority for the Administrative County of Norfolk is satisfied that to facilitate the holding of the City of Norwich Half Marathon the roads set out in Article 1 above should be subject to the following restrictions:

- 1) 1030hrs to 1215hrs (1 hour 45 minutes).
- 2) 1045hrs to 1130hrs (1 hour 45 minutes).
- 3) 1050hrs to 1155hrs (1 hour 5 minutes).
- 4) 1100hrs to 1225hrs (1 hour 35 minutes).

- 5) 1105hrs to 1300hrs (1 hour 55 minutes).
- 6) 1120hrs to 1300hrs (1 hour 40 minutes).
- 7) 1130hrs to 1330hrs (2 hours).

3. Nothing in Article 2 of this Order shall apply:

- a) to anything done with the permission or at the direction of a police constable in uniform;
- b) to any vehicle being used for police, fire brigade or ambulance purposes, or the purposes of a statutory undertaker in an emergency which necessitates the bringing of vehicles into a section of road to which this Order applies.

4. Insofar as any provisions of this Order conflicts with any provisions of any previous Order relating to the lengths of road specified in the Schedule to this Order, that provisions of this Order shall prevail

NOW THEREFORE the Norfolk County Council DO HEREBY ORDER, that with effect from 15<sup>th</sup> April 2018 for the duration of the race the use of the said roads i) SHALL BE SUBJECT TO a one way restriction and the use of the said road ii) SHALL BE RESTRICTED
